In 1991, Mr. Poticha formed Design Construction Concepts. In its inception, Design Construction Concepts was commissioned for small custom residential projects that the firm designed. During the past 32 years, Design Construction Concepts has expanded to include the execution of small and large scale residential and commercial projects created by other Architects and Interior Designers.

In 2005, Mr. Poticha helped form Mosaic Construction, a national design-build construction industry leader delivering high quality renovation, remodeling, and building services for multifamily, commercial, and government/non-profit properties.



In 2014, Mr. Poticha founded Cannabis Facility Construction (CFC), a division of Mosaic Construction, which is a national, industry leader in full-service cannabis facility design-build who has worked on over 80 cultivation facilities, processing centers, and dispensary projects in 13 states.

Andy earned his Bachelor of Architectural Studies in 1988, and his Master of Architecture in 1990 from the University of Illinois Urbana.

THE FUTURE OF THE CANNABIS INDUSTRY IN ILLINOIS

Wendy Berger

CEO and President WBS Equities, LLC

Wendy A. Berger is principal of WBS Equities, LLC. WBS Equities specializes in ground-up construction, renovation, development, sale lease back transactions and acquisition of industrial buildings for food and beverage manufacturers and distributors. Wendy founded the firm in 2014.

Wendy serves as a Director of the Board at Green Thumb Industries Inc. (GTI) (CSE: GTII)

(OTCQX: GTBIF) (2015 – present). GTI is a national cannabis consumer packaged goods company and retailer. GTI's brands include, Dogwalkers, The Feel Collection, incredibles and Beboe, among others. GTI has 13 manufacturing facilities, 40 retail stores open, licenses for 96 retail locations and operations across 12 states in the United States.

Over the last 30 years she has been involved in the real estate business as a developer, lender, property manager, broker and investor. Wendy began her career at American National Bank and Trust Company of Chicago (a subsidiary of First Chicago, now JP Morgan Chase) in Commercial Lending. Wendy spent several years as a principal with Berger Realty Group, an 80-year- old family owned Real Estate business where she focused on residential and industrial property management and development. She was responsible for managing 3,000 apartment units, 200,000 square feet of commercial space and 250,000 square feet of industrial space.

Aside from her experience in the real estate field, Wendy spent 10 years working with technology startups. Wendy was employee number 11 at Orbitz, the Travel web site founded in 2000 by American, Continental, Delta, Northwest and United Airlines. Wendy was Director of the Enterprise Planning at Orbitz and focused on strategic planning. Prior to Orbitz, Wendy co-founded and was COO of Neoglyphics Media Corporation, one of the country's first web site development firms. Neoglyphics grew quickly from a small start-up to a to a leader in the industry before it was sold to a publicly traded company in March 1998 for \$65 million.

Wendy earned her MBA in Finance and Real Estate from Northwestern University's Kellogg School of Business. She received a B.S., cum laude, in Finance and Marketing from Syracuse University.

In her spare time Wendy is an avid triathlete and runner, having completed 39 Olympic Distance triathlons and 8 half-marathons.

Wendy serves on the Board of directors of the Chicago Public Library Foundation (2016 – present) and chairs the Governance Committee. She is also on the Board of directors of the Jewish Federation/Jewish United Fund of Chicago (2001 – 2007, and 2009 – present), is a Vice-Chair and served as the 2019 General Campaign Chair which raised a record setting \$89 million dollars. Among her responsibilities as a Board Member of JF/JUF, Wendy helped to develop and led the first two classes of the Jewish Leaders Institute. Wendy also serves on the Board of Directors the Secure Community Network (SCN), the official safety and security organization of the Jewish community in North America. Wendy was a participant in the 2011 class of Leadership Greater Chicago. Wendy is a graduate of the Wexner Heritage Program, a two-year study program founded and funded by Les Wexner, Founder and CEO of Limited Brands. Wendy was a member of the United Jewish Communities National Young Leadership Cabinet (1998 – 2004), The Hillels of Illinois Governing Commission (1996 – 2014), was the Chair of the JUF High Tech Committee (2000 – 2003).

Wendy is an avid hands on volunteer and currently serves as a volunteer for several Chicago based charitable organizations. Wendy served until 2004 as Vice-President and Membership Chair at The Standard Club of Chicago and as a member of the Board of Directors (1994 – 2004). Wendy is also a member of the Economic Club of Chicago and served as the chair of the Real Estate Membership Committee. Wendy served two years on the Board of Directors of TEDxMidwest, the locally and independently organized TED event. TED is a nonprofit devoted to Ideas Worth Spreading. In 2014 Wendy co-founded Illinois Women in Cannabis, an organization with the mission of ensuring that women would be at the starting line of the emerging legal Cannabis industry – an industry too new to have a glass ceiling – rather than playing catch up.

Barrington Rutherford joined Combs Global as its Chief Operating Officer in November 2022. Combs Global owns and operates a growing portfolio of leading companies spanning media, television, spirits, fashion, e-commerce, consumer products, and cannabis.

Founded in 2013, the Combs Global portfolio has since expanded to include Bad Boy Entertainment, CÎROC Ultra Premium Vodka, Deleón Tequila, REVOLT Media & Television, Empower Global, Sean John, Aquahydrate, Love Records, Our Fair Share, Capital Prep Charter Schools.



Prior to joining Combs Global, Barring served as Cresco Labs' Senior Vice President of Real Estate and Community Integration, Barrington Rutherford supported the company in the growth of its operations from one state to nine. Under his leadership, Cresco's real estate team successfully negotiated numerous real estate transactions that led to prime locations for the company's cultivation, manufacturing and dispensary locations.

In a highly regulated industry where each state's cannabis program has a different and precise requirement for operation, he focuses on ensuring that all the company's locations are compliant with local and state regulations. Mr. Rutherford also oversaw Cresco's social equity and justice initiatives. Under his stewardship, the SEED (Social Equity & Educational Development) initiative works to develop tangible pathways into the cannabis industry for communities impacted by the War on Drugs through a commitment to restorative justice in the form of partnerships, sponsorships, and developing justice-oriented programming. His community-first strategy has the SEED initiative focusing on three core areas: Restorative Justice, Education & Workforce Development, and Community Business Incubator. The program has contributed over \$1.5MM to date to initiatives, activations and organization's in Cresco's local communities.

Prior to his tenure at Cresco Labs, Mr. Rutherford has enjoyed an acclaimed entrepreneurial career as a real estate developer and fast-food restaurant franchisee. His real estate experience dates to 2003 and includes both residential and commercial development, both new and adaptive reuse projects including office facilities, churches, gymnasiums, childcare facilities and multifamily housing developments around the country.

He has served on the board of directors of several community organizations in the Chicago area and was the founding Treasurer of the Board of Directors of the Amandla Charter School in the Englewood neighborhood on Chicago's South Side. In 2019, he was elected Treasurer of the Board of Directors of the New York Medical Cannabis Industry Association and to the Board of Directors of the Minority Cannabis Business Association. Mr. Rutherford is currently a board member of the New York Urban League.

Mr. Rutherford graduated from DePaul University with a bachelor's degree in Economics.
